

## C1R Novelty Minimum Advertised Pricing Policy & Agreement (MAP)

Channel 1 Releasing (C1R) actively supports the advertising and promotion of its' products by its' resellers. Effective October 1, 2016, a new Minimum Advertised Price (MAP) on all Rascal/Boneyard products will be in effect. We have implemented this MAP policy to preserve our strong reputation for providing customers with high value products to protect us all. We greatly appreciate the efforts of all resellers to distribute our products and support their customers. The MAP policy shall work under the following guidelines:

- The MAP for all Rascal/Boneyard products shall be no more than **25%** less than the published Manufacturer's Suggested Retail Price (MSRP), for a maximum of 2 weeks of each year. Current MAP pricing can be found through your sales rep or online at C1R.com.
- The MAP policy applies to all Rascal/Boneyard novelty prices advertised in newspapers, catalogs, direct mail pieces, faxes, radio, television, email promotions, or anywhere on the Internet, that means including Amazon. Internet auctions may not display or have reserved bid or other acceptable prices below the MAP price.
- The MAP policy is not applicable to any in-store advertising that is displayed only in the store and not distributed to any customer(s).
- If you are reselling Rascal/Boneyard products to another reseller you are responsible for that reseller adhering to this MAP policy.
- MAP applies only to advertised prices and does not apply to the price at which the products are actually sold or offered for sale to an individual consumer within the dealer's retail location or over the telephone.
- MAP does not establish maximum advertised prices. All resellers may offer Rascal/Boneyard products at any price in excess of the MAP.
- Intentional or repeated failure to abide by this policy will result in termination of Rascal/Boneyard product sales. Rascal/Boneyard does not intend to do business with resellers who degrade the image of Rascal/Boneyard and its products.

This MAP policy has been established by Rascal/Boneyard to help ensure customer recognition of Rascal/Boneyard as a top producer of high quality novelties and to protect the reputation of its name and products. The MAP policy is also designed to ensure retailers have the incentive to invest resources into services and promotions for Rascal/Boneyard products.
